1. Mizoram Rural Bank, established on 27th September, 1983 under the Regional Rural Bank Act 1976 (hereinafter referred to as "The Bank") invites 'Sealed Tender' from established and experienced agencies for supply of Laptop and Desktop Computer (Full set) along with Windows operating system with valid license key at Mizoram Rural Bank, Head Office, Aizawl, Mizoram. 2. Tender methodology proposed to be adopted will be two bid systems i.e. Technical Bid and Commercial Bid. The Bank will enter into contract with successful bidder out of the bidders who has been determined to qualify in technical bid and commercial bid.
3. **Minimum eligibility criteria/Pre-qualification criteria:** Vendor who fulfil the following criteria only should submit the bid:
- a) Bidder should be registered in India.
 - b) Bidder should have at least two (2) years of experience in the field of sales and services business of computer hardware and peripheral. **Relevant document should be submitted.**
 - c) Bidder should have Original Equipment Manufacturer (OEM) presence in India or channel partner's/service providers, authorized distributors/dealers/retailers.
 - d) The bidder should have sufficient experience and proper infrastructure to provide requisite after sales service and support in the state of Mizoram. On-site service within two (2) working days should be provided during warranty period.
 - e) The bidder should be a profit-making entity for the last two (2) years.
 - f) The bidder should submit documentary evidence in support of fulfilling eligibility criteria mentioned in the document along with information.
 - g) The bidder should have valid GST Registration and valid License from government authority. **Copy of GST Registration certificate should be submitted.**

6. **Two Parts Bid:** The offer in two separate sealed envelope marked as "Technical offer for supply of 20 Laptops/100 Desktop computer" and "Commercial offer for supply of 20 Laptops/100 Desktop computer" and super scribed by "Supply of 20 Laptops/100 Desktop Computer" addressed to the address mentioned in Sl. No. 1 in office not later than 15:00 of 30th July, 2022. Each page of the quotation document must be signed with proper seal of the vendor/bidder.
7. **Envelope No. 1 (Technical bid)** should contain the following:
- i. Transaction detail for Bid Security/Security deposit of ₹ 90,000.00 for Desktop and ₹ 14,000.00 for Laptop.
 - ii. A copy of proposal document including all annexures signed by authorized signatory of the bidder on each page
 - iii. Letter for Acceptance of Terms and Conditions given in Annexure-IV of the tender.
 - iv. Manufacturer Authorization Form
 - v. Detailed specification of the hardware part
 - vi. Detailed specification of the software part (if any)
 - vii. An undertaking by authorized signatory of the bidder on the letterhead of the bidder, stating that the bidder has not been blacklisted by any Central/State Government or PSU for any corrupt and fraudulent practice.
 - viii. Statement showing implementation experience detail.
 - ix. Letter for technical clarification (if any)
 - x. An undertaking to provide support for the hardware and software part during the entire period of warranty.
 - xi. Relevant document for experience.
 - xii. GST Registration Certificate

It should be noted that the content of technical offer should not reveal commercials.

8. **Envelope No. 2 (Commercial bid)** should contain:
- i. The Bill of quantities as per specification and the most competitive prices offered in respect of the item therein as per Annexure I.
 - ii. Prices should be in Indian Rupee only with detailed breakup of prices as per Annexure III. The commercial offer should not contradict with the technical bid in any manner.

9. **Earnest Money Deposit (EMD)/Bid Security Deposit**

- i. EMD will not carry any interest.
- ii. The bidder has to do online transaction for submission of EMD amount of ₹ 90,000.00 (Rupees ninety thousand only) for Desktop and ₹ 14,000.00 for Laptop in Mizoram Rural Bank's Account mentioned below:

- iii. A bid without the required EMD shall be summarily rejected.
- iv. Bid security/EMD of unsuccessful bidder will be refunded without interest within reasonable time after final decision of the bidding process. Bid security of successful bidder will be returned only upon the vendor's completion of delivery of item. EMD stands forfeited in case the bidder withdraws or amends its bid after submission of tender document.
- v. MSME registered vendors are exempted from EMD deposit. However, they will have to submit relevant document to prove that they are officially registered MSME vendor.

10. The bidder should submit all relevant documents along with tender document including annexures.
11. Successful bidder should deliver at Head office of the Bank, all desktop computer sets and laptop within a period of three (3) weeks from the issue of purchase order.

12. **General Terms and Conditions**

12.0. **Scope of Work : The successful bidder should provide the following services:**

12.0.1. **Supply:**

- a) Desktop computer set with pre-loaded genuine licensed Windows 10 operating system with Monitor, Mouse, Keyboard and other peripherals.
- b) Laptop with pre-loaded genuine licensed Windows 10 operating system
- c) Manual of the hardware and software (wherever applicable)
- d) Media in the form of CD, DVD, etc (wherever applicable)

12.0.2. **Warranty Support:**

The successful bidder has to provide comprehensive post-delivery warranty support for all hardware and software supplied as per bid for a period of three (3) years on-site.

- 12.1. Specific authorization from the original manufacturer of the hardware and software (wherever applicable) would be required for the tender.
- 12.2. Complete specification of the hardware as per the proposal have to be provided along with the technical bid.

- 12.3. The Bank reserves the right to reject any particular bid or all bids without assigning any reason whatsoever. Failure to select a bidder shall not make the Bank liable to pay claim.
- 12.4. The bidder acknowledges the responsibility to respond promptly in contract with the Bank by submitting the proposal against this Tender. Failure to do so shall relieve the Bank of any contractual obligation to the bidder and the Bank reserves the right to select any other bidder for the awarded work.
- 12.5. Any additional/different terms and conditions proposed by the bidder shall be treated as rejected unless expressly assented in writing by the Bank.
- 12.6. Tender received late after last date of submission on account of any reason will not be entertained.
- 12.7. No expenses incurred by the bidder in preparation of the bid against the tender enquiry shall be borne by the Bank. The submitted bid once opened shall not be returned to the bidder.
- 12.8. The price quoted for all computer set in the proposal should be competitive. The Bank reserves the right to verify independently and rejects bid not complying with the criteria. Quoted price should include all local taxes, GST, duties, transportation cost and insurance cost (if any) till items are accepted.
- 12.9. The prices quoted shall be valid for a minimum period of three months from the last date of submission of offer.
- 12.10. Any problem in the hardware or software part arising during the warranty period shall be rectified or replaced at no extra cost to the Bank.
- 12.11. Successful bidder will be responsible for delivery of item at final location i.e. Head Office of the Bank and all expenses to this effect shall be borne by the bidder.
- 12.12. The successful bidder shall not assign to others, in whole or in part, their obligation to perform under the contract, except with prior written permission of the Bank.
- 12.13. Product shall be supplied in a ready to use condition along with all required cables, connectors, software drivers, manual, media, etc.
- 12.14. Original copy of supplier's invoice and warranty certificate have to be furnished by the supplier.
- 12.15. The Quotation must be filled in English only and amounts should be written in both figures and words.
- 12.16. **Terms of Payment:** No advance payment will be made and 100% payment will be made only after successful delivery of the item at the Bank's Head office building. The supplier will be required to furnish Tax invoice and proof of delivery while claiming payment.
- 12.17. **Warranty:**
 - 12.17.1. During the warranty period of three (3) years from the date of purchase, bidder shall provide onsite free maintenance services for troubleshooting of hardware and replacement of parts at no extra cost.
 - 12.17.2. The bidder warrants that the goods supplied against this tender are standard, new, unused and as per specification in the tender document.
- 12.18. The successful bidder will make arrangement of spare parts for the hardware available for a minimum period of three years (warranty period) from the time of delivery of the item. If any of the parts are not available during the warranty period, substitution shall be carried out with parts equivalent of higher capacity.
- 12.19. **Indemnity :** The successful bidder shall, at its own expense defend and indemnify the Bank against any third-party claims in respect of any damages or compensation payable in consequences of any accident or injury sustained or suffered by its employee or agents. The successful bidder shall indemnify, protect and save the Bank and hold the Bank harmless from and against all claims, losses, costs, damages, expenses, action suits and other proceedings, relating to or resulting directly or indirectly from (i) an act or omission of the bidder, its

employees or its agents in the performance of the service provided by this contract (ii) breach of any of the terms and conditions of this tender or breach of any representation or warranty by the bidder (iii) use of the deliverable and or services provided by the bidder (iv) infringement of any patent, trademarks, copyright, etc or such other statutory infringements in respect of all component provided to fulfil the scope of this tender. The successful bidder is required to submit a "Letter of Indemnity and undertaking" as per format given Annexure V.

12.20. Performance Bank Guarantee: The successful bidder shall, at his own expense, deposit with the General Manager, Mizoram Rural Bank, Head Office, Aizawl within 10 days of raising Purchase order, a Performance Bank Guarantee from a scheduled commercial bank including RRBs, payable on demand as per format given in Annexure-VII for an amount equivalent to 10% of the total order value for the due performance and fulfilment of the warranty of the bidder.

12.21. No Price Variation: The offered price shall be on a fixed price basis. No upward revision in the prices would be considered on account of any subsequent upward change in government taxes, duties, changes of price by original manufacturer, etc. However, if there is any downward revision on account of any government taxes, etc and reduction by original manufacturer, the same shall be passed on to the Bank.

12.22. Order cancellation : MRB reserves the right to cancel the entire/part of the work of the contract at any time by assigning appropriate reasons in the event of one or more of the following conditions:

- i) Delay in delivery of the ordered equipment i.e. beyond 3 weeks from the date of Purchase Order
- ii) Any other appropriate reason in view of the Bank

12.23. Right to Accept/Reject the Quotation: MRB does not bind itself to accept the lowest bid or any or all quotations and reserves the right to accept or reject any or all quotations either in whole or in part without assigning any reasons for doing so.

12.24. Right to alter order quantity and specification: MRB reserves the right to alter technical specification and or quantity of ordered item on the same terms and condition.

13. Evaluation of Bids

13.1. Quotation received on or before the stipulated date and time for responding to the tender only will be considered for further evaluation.

13.2. In the first stage, Pre-qualification/Technical bid will be opened in the presence of Bid Opening Committee appointed for the purpose. It is the responsibility of the bidder's representative to be present at the time, date and at the place communicated for the purpose.

13.3. Bid opening committee will examine bids to determine whether they are complete, properly signed, supporting document attached and are generally in order. BOC may, at its sole discretion, waive any minor infirmity or non-conformity or irregularity in a bid which does not constitute any material deviation. BOC will have the authority to reject or accept the bid for further examination.

13.4. Only bidders who qualify in pre-qualification and technical evaluation would be shortlisted for commercial evaluation.

13.5. Final decision will be made by the Bank after commercial bid evaluation is over. Here it should be noted that lowest bidder is not necessarily and automatically the winner of the bid.

Final selection will be made based on technical evaluation, commercial evaluation and other aspects which the Bank may find it necessary for the best interest of the bank.

- 13.6.** Bid evaluation will be done separately for Desktop and Laptop and Purchase order will also be raised separately for both.

14. Award of contract/Purchase order

14.1. The Bank will raise purchase order separately to the successful bidder out of the bidders who have responded to the tender, who has been determined to qualify to perform the task mentioned in the tender satisfactorily. Separate purchase order will be raised for supply of Desktop and Laptop.

14.2. The bank reserves the right to increase or decrease the quantity of items which was originally specified while floating tender without any change in unit price or any other terms and conditions.

14.3. The lowest offer evaluated by the committee will normally be recommended. However, the committee may recommend a vendor other than the lowest quoting vendor. This may be necessitated by other commercial terms and factors such as past experience, after sales service and support, etc.

Mizoram Rural bank, established on 27th September, 1983 under the Regional Rural Bank Act 1976 having its **Head Office at MINECO, Aizawl, Mizoram** (Hereinafter referred to as "**MRB**" which expression shall unless repugnant to the content and meaning thereof, means and includes its successors and assigns)

WHEREAS

(1) MRB is desirous of purchasing 20 Laptops/ 100 Desktop Computer sets (Model No : _____) at its Head Office in Aizawl (hereinafter referred to as "**the said work**") and has requested _____ a _____ registered/established/constituted under/by _____

Act having its Registered Office at _____ (hereinafter referred to as "Contractor" which expression shall unless repugnant to the context and meaning thereof means and includes its successors and assigns) to submit its Bid to execute the said work.

2. The Contractor has submitted his Bid/quotation to execute the said work for a total sum of ₹ _____ (Rupees _____ only).

3. One of the conditions of the said quotation is that the Contractor shall furnish to MRB a Performance Bank Guarantee (PGB) for an amount of 10% of the total value order of 100 Desktop Computers (Model No : _____) i.e. _____ (Rupees only) in favour of Mizoram Rural Bank, Head Office for the due and faithful performance of the contract in all respects as per the conditions as set forth in the Tender document.

4. The Contractor has approached us for issuing a PGB in favour of MRB for an amount of (Rupees _____ only).

NOW THEREFORE THIS DEED OF GUARANTEE WITNESSETH THAT

a) In consideration of the premises and at the request of the contractor. We _____ (Name of the Bank) both hereby irrevocably and unconditionally guarantee to pay to MRB, forthwith on mere demand and without any demur, as may be claimed by MRB to be due from the contractor by way of loss or damage caused to or would be caused to or suffered by MRB by reason of failure to perform the said works as per the said contract.

b) Notwithstanding anything to the contrary, the decision of MRB as to whether computer hardware and software have failed to perform as per the contract and go whether the contractor has failed to maintain the computer hardware and software as per the terms of the contract will be final and binding on the Bank and the Bank shall not be entitled to ask MRB to establish its claim or claims under this Guarantee but shall pay the same to MRB forthwith on mere demand without any demur, reservation, recourse, contest or protest and/or without any reference to the contractor. Any such demand made by MRB on the Bank shall be conclusive and binding notwithstanding any difference/dispute between MRB and the contractor or any dispute pending before any Court, Tribunal, Arbitrator or any other authority.

c) This Guarantee shall expire at the close of business hours on _____ (this date should be the date of expiry of the warranty plus 180 days) without prejudice to MRB's claim or claims demanded from or otherwise notified to the Bank in writing on or before the said date i.e., (this date should be date of expiry of Guarantee. i.e. 6 months after end of warranty/contract period).

d) The Bank further undertakes not to revoke this Guarantee during its currency except with the previous consent of MRB in writing and this Guarantee shall continue to be enforceable till the aforesaid date of expiry or the last date of the extended period of expiry of

Guarantee agreed upon by all the parties to this Guarantee, as the case may be, unless during the currency of this Guarantee all the dues of MRB under or by virtue of the said contract have been duly paid and its claims satisfied or discharged or MRB certifies that the terms and conditions of the said contract have been fully carried out by the contractor and accordingly discharges the Guarantee.

e) In order to give full effect to the Guarantee herein contained, MRB shall be entitled to act as if the Bank is MRB's principal debtors in respect of all MRB's claims against the contractor hereby Guaranteed by the Bank as aforesaid and the Bank hereby expressly waives all its rights of surety ship and other rights, if any, which are in any way inconsistent with the above or any other provisions of this Guarantee. 6). The Bank agrees with MRB that MRB shall have the fullest liberty without affecting in any manner the Bank's obligations under this Guarantee to extend the time of performance by the contractor from time to time or to postpone for any time or from time to time any of the rights or powers exercisable by MRB against the contractor and either to enforce or forbear to enforce any of the terms and conditions of the said contract, and the Bank shall not be released from its liability for the reasons of any such extensions being granted to the contractor for any forbearance, act or omission on the part of MRB or any other indulgence shown by MRB or by any other matter or thing whatsoever which under the law relating to sureties would, but for this provision have the effect of so relieving the Bank.

f) The Guarantee shall not be affected by any change in the constitution of the contractor or the Bank nor shall it be affected by any change in the constitution of MRB by any amalgamation or absorption or with the contractor, Bank or MRB, but will ensure for and be available to and enforceable by the absorbing or amalgamated company or concern.

g) This guarantee and the powers and provisions herein contained are in addition to and not by way of limitation or in substitution of any other guarantee or guarantees heretofore issued by the Bank (whether singly or jointly with other banks) on behalf of the contractor heretofore mentioned for the same contract referred to heretofore and also for the same purpose for which this guarantee is issued, and now existing un cancelled and we further mention that this guarantee is not intended to and shall not revoke or limit such guarantee or guarantees heretofore issued by us on behalf of the contractor heretofore mentioned for the same contract referred to heretofore and for the same purpose for which this guarantee is issued.

h) Notwithstanding anything to the contrary contained herein, the Bank further agrees to accept the notice of invocation as a valid claim from the beneficiary of this Guarantee, should such occasion arise, at any of its branches operating in India including the issuing branch on the day of such invocation and if such invocation is otherwise in order.

i) It shall not be necessary for MRB to exhaust its remedies against the Contractor before invoking this guarantee and the guarantee therein contained shall be enforceable against us not withstanding any other security which MRB may have obtained from the Contractor at the time when this guarantee is invoked is outstanding and unrealized.

j) Any notice by way of demand or otherwise under this guarantee may be sent by special courier, fax or registered post accompanied by the copy of the guarantee.

k) Notwithstanding anything contained herein: -

1) Our liability under this Bank Guarantee shall not exceed and is restricted to _____ (Rs. _____ only).

2) This Guarantee shall remain in force up to _____ or up to the date extended by renewal of this guarantee.

3) Unless the demand/claim under this guarantee is served upon us in writing before _____ or on or before the expiry of six months from the validity date extended by renewal of this guarantee. All the rights of MRB under this guarantee shall stand automatically forfeited and we shall be relieved and discharged from all liabilities mentioned hereinabove.

1) The Bank has power to issue this Guarantee under the statute/constitution and the undersigned has full power to sign this Guarantee on behalf of the Bank.
